Terms of Employment:

The position involves working for approximately 2.25 hours each day that school is in session for 180 days (7:30 am -9:00 am and 3:15 pm - 4:00 pm, M, T, TH, F and 2:00 pm - 2:45 pm W). Compensation is provided at an hourly rate determined by the Bethlehem Police Department. The role does not include benefits. The Bethlehem Police Department will provide training for the Crossing Guard position.

CRITERIA FOR SELECTION:

The position holder must be able to perform the essential job functions with or without reasonable accommodation. The employee is responsible for informing Charter Arts of any and all reasonable accommodations that will be required.

- Controls vehicular traffic as necessary and consistent with the safety of all concerned to ensure safe crossing for students
- Directs students to cross the street at the designated areas
- Controls traffic with the assistance of a hand-held stop sign
- Wears a safety vest while directing traffic and/or crossing students
- Instructs all school students to walk at the crossing point
- Must be dependable and punctual
- Must have good attendance

PHYSICAL QUALIFICATIONS:
